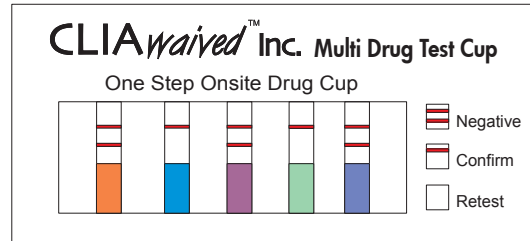

TEST PROCEDURE:

1. Urinate into the cup, filling the cup with urine above the minimum level line.
2. Wait 5 minutes.
3. Read the results.
4. Refer to product insert for detailed instructions.
